CALLING ALL PLAYERS SOCCER CLINIC
SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: 2022 MexTour Send-Off Calling All Players Soccer Clinic Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia, and Canada (excluding Quebec) (the “Territory”) who are twenty-one (21) years of age or older at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Major League Soccer, L.L.C. (“MLS” or “Sponsor”) and Soccer United Marketing, LLC (“SUM” and together with Sponsor, the “Sponsor Entities”) and each of their respective parents, affiliated companies, member clubs, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, provincial, state and local laws, rules and regulations. Void outside Territory, in Quebec and where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: The Sweepstakes begins at 9:00 am Eastern Standard Time (“EST”) on Wednesday, September 14, 2022 and ends at 8:00 pm EST on Monday, September 19, 2022 (“Entry Period”). During the Entry Period, there is one way to enter. No other method(s) of entry will be accepted. All information and files submitted in the format specified will become property of Sponsor and used as provided in the MLS Terms of Use and Privacy Policy, each of which can be found by visiting <http://www.mlssoccer.com/terms-service> and <http://www.mlssoccer.com/privacy-policy> (both of which are incorporated herein by reference).

1. Online Method: During the Entry Period, visit MexTour.org to register to participate in this youth clinic with your child who is between the ages of 10-12 years old the Rose Bowl Stadium. Register for the sweepstakes by filling out the required fields on the [Schedule](#) page which will include:

- 1) **Complete Name**
- 2) **E-mail address**
- 3) **Date of Birth of the Youth Participant**
- 4) **Area Code and Telephone Number**
- 5) **ZIP code**

Once completing the entry form with the information requested, follow the on-screen instructions to submit your entry. By submitting your completed entry form and all other requested information as directed, you will receive one (1) entry in the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete entries are void. Online entrants to the Sweepstakes will be given the option to receive commercial e-mails from Sponsor Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant’s consent to receive such e-mails and consenting to do so will not increase your chances of winning.

RANDOM DRAWING: Five (5) potential winner of the Sweepstakes will be selected by random drawing on or about Monday, September 19, 2022 from among all eligible entries received by the

Sponsor. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period.

PRIZE: One Grand Prize is Available (the “Prize”):

- (i) Prize consists of an invite for you and your child to the 2022 MexTour Send-Off CAP Soccer Clinic. The approximate retail value of the Prize is \$500.

The Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor’s sole and absolute discretion. Sponsor reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion. MLS game, event, and exhibition dates and times are determined in the sole discretion of MLS and/or the applicable MLS team, as applicable, and may be subject to change. Any and all transportation to/from the match and any corresponding accommodations will not be provided by Sponsor and will be each winner’s sole responsibility. Tickets must be used on the date specified by Sponsor. Tickets are subject to certain terms and conditions as specified thereon. Seat locations will be determined by Sponsor. Winner and their guests must comply with all venue rules and regulations. Failure to do so may result in forfeiture of prize.

NOTIFICATION: The potential winner will be notified by e-mail and/or telephone (in the sole discretion of Sponsor and/or the applicable MLS Entity, as applicable) by the Sponsor. In the event that any potential winner does not respond to any such notification within twenty-four (24) hours of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate potential winner may be chosen from among all remaining eligible entries. Sponsor, in its sole discretion and time permitting, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential winner is a resident of Canada, such potential winner will be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered by telephone. If such potential winner answers the skill-testing question incorrectly, as determined by Sponsor in its sole discretion, they will be disqualified, the Prize will be forfeited and, at Sponsor’s discretion and time permitting, an alternate potential inner may be chosen from among all remaining eligible entries. The potential winner will be required to sign and return an Affidavit of Eligibility (or, if a resident of Canada, a Declaration of Eligibility) and Release of Liability and, unless prohibited by law, Release of Publicity, prior to receiving Prize. A disqualification will result, the Prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries if all required documents are not properly executed and returned within the specified period of time. Refusal or return of such documents as non-deliverable or winner’s noncompliance with these Official Rules will also result in disqualification and forfeiture of the Prize and, at Sponsor’s sole discretion and time permitting, may cause an alternate winner to be selected from among all remaining eligible entries. Winner shall be solely responsible for all federal, state and/or local taxes, and the reporting consequences thereof, and for any other fees or costs associated with the Prize.

Any attempt to deliberately damage the content or operation of this Sweepstakes is unlawful and subject to legal action by the Sponsor, the other Sponsor Entities and/or their respective agents. Sponsor and the other Sponsor Entities shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Sweepstakes, and to resolve all disputes in their sole discretion. Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. All disputes will be resolved under applicable U.S. laws in the County of New York, state of New York without giving effect to choice of law or conflicted law principles (whether of the state of New York, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state

The Sponsor and the other Sponsor Entities, as applicable, reserve the right, in their sole discretion, to cancel or suspend the Sweepstakes for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes. In the event of cancellation, Sponsor may elect to identify the Winner and award the Prize from among all non-suspect, eligible entries received up to the time of such cancellation.
