2022 Annual Renewals Now Due

Per the PHiP Bylaws, Annual Renewal forms and payments are to be received by January 31st.

Your annual renewal packet must contain the following items :

> A completed & signed renewal application.
> Please use the official name of your club.



- PHiP contact for your club This is the person, email address, phone number and mailing address where all official PHiP information will be sent and listed on the PHiP chapter page.
- Total money raised/donated and volunteer hours for the entire year.
- Please complete the form for the Board members you want on the Club Leaders Board. Even if you have sent this information already, you must fill out this required form.
- An official club roster as of 12/31/21, complete with name, address, phone & e-mail.
- A separate complete list of Club Officers, with address, phone number and email listed.
- A synopsis of your club's participation in charitable, environmental, and community events/activities, including dollars raised/contributed, volunteer hours expended and/or goods/services rendered. Please include contact name.
- Payment in full of annual dues. Dues will remain the same: \$75.00 per chapter + \$1.00 per head in excess of 75 members. If sending a check, it should be payable to Parrot Heads in Paradise.

ALL chapters must submit a signed renewal application, regardless of charter date. Newlysanctioned chapters with no activity to report should so state. Electronic signatures are acceptable.

Chicago PHC Wins Golden Coconut

Every year Meeting of the Minds features a panoply of the biggest names in the Trop Rock music genre, but perhaps the most eagerly and anxiously awaited moment comes on Saturday morning when the Golden Coconut is awarded. This whimsical trophy has been awarded since 1996 by PHiP and Margaritaville to the club best epitomizing the spirit and charitable contributions of all Parrot Head clubs in a blind essay submitted to a panel of judges.

This year's winning club was the Chicago Parrot Head club, becoming the fourth club to win the coconut twice.

In winning the award Chicago PHC started with an impressive resume of charitable and environmental fundraising and service. Some of the charities supported by Chicago PHC were a local food bank, an animal rescue mission, an after school program for inner city youth, a highway clean up program, a care facility for the developmentally disabled, Alzheimer's Association, Toys for Tots, and even the local zoo. Chicago Parrotheads donated not just money but themselves to these causes.

Chicago Parrotheads combined their charity work with a wide variety of entertainment from pool parties to Hawaiian themed monthly meetings to organizing and hosting one of the largest Trop Rock events in the country. All this was accomplished despite the continuation of the difficulties of the Covid-19 environment.

In the end however, the Golden Coconut award is an essay contest, and Chicago PHC put together a whimsical tale narrated by a parrot observing from above. The story is loaded with lyrics and references to many Buffett songs. Read this year's winning essay <u>here</u> and see how many songs you can identify.

So let's all raise our margarita glasses and give a big Phins Up to this year's Golden Coconut award winners, the Chicago PHC, for a job well done and well written.

He Oughta Be (and Has Been) in Pictures

It's a common feature of American culture. Whenever people acquire a degree of fame, their desires often turn to being in the movies.

Singers want to become actors. Actors feel the urge to sing. Jimmy Buffett is no exception. Over the years Buffett has been in a number of motion pictures, mostly in cameo roles.

Buffett's first movie role came as a result of his friendship with Tom McGuane. McGuane was Buffett's landlord in Key West during Buffett's early days there, and they became friends, a



good thing too since McGuane later married Buffett's sister Laurie.

McGuane was a novelist and screenwriter and had written a script for a quirky Western comedy about cattle rustlers titled *Rancho Deluxe*. Buffett was signed on to write the musical soundtrack, and in the summer of 1974, he, future wife Jane Slagsvol and Roxy Rodgers drove out to Livingston, Montana where the movie was being filmed. *Livingston Saturday Night* was the most memorable song, and Buffett performs the song in the movie as a country western singer in a rowdy bar in Livingston.

Buffett repeated his performance in the 1978 film *FM*, a comedy/drama about the internal conflicts at an FM radio station. His appearance in the film wasn't especially noteworthy, however. Also performing in *FM* were Tom Petty, Linda Ronstadt and REO Speedwagon.

Buffett On the Screen (Cont.)

Buffett didn't appear on the silver screen again until 1984 when he began a series of cameo appearances. First was in *Repo Man*, a low budget flick about a repossession agency attempting to obtain a 1964 Chevy Malibu with a top secret cargo in the trunk. Buffett appeared in the film as one of the repossession agents.

Buffett later appeared as a shoe stealing pirate in the 1991 fantasy *Hook*, and in the 1994 baseball flick *Cobb* as the armless heckler Ty Cobb attacks in the stands.

If you are especially attentive when you go to the movies, you might have noticed Buffett as a 727 pilot in the 1995 adventure, *Congo*, and as a marine studies teacher in the 2006 film, *Hoot*.

Product placement is a big money maker in movies today, and the Isla Nublar resort in the 2015 hit, *Jurassic World*, had enough big name retailers to fill an upscale shopping mall, one of which was *Margaritaville*. When the flying, carnivorous, pteranodons escape the aviary and begin attacking the tourists, a bartender, who looks a lot like Jimmy Buffett, can be seen fleeing *Margaritaville* with a margarita in each hand. As is typical for him, he forgot to save the shaker of salt.

Granted, Buffett's appearances in motion pictures have been brief. However, his roles have been more lasting on the small screen. Buffett appears in seven episodes of the series, *Hawai'l Five* -*O*, as helicopter pilot Frank Bama.

Buffett's most recent acting role was as himself, with a bit of a twist, in the January 14th episode of police drama, *Blue Bloods*. If any Parrotheads missed it, they should catch it when it become available for streaming and enjoy the phun. Buffett in the Movies

In the midst of a pandemic, hardy groups of partiers still found ways to provide much needed help to their communities. They are known as Parrot Heads. These are their stories.

The **Central Illinois Parrot Head Club** volunteered at the Ann Benjamin TCRC camp picnic on September 24. They conducted games and activities for the special needs young adults in the program. Five members attended the Walk to End Alzheimer's

in Peoria, Illinois on October 2 and raised \$730. The club donated \$100 of toys, and 109 coloring books and crayons to the Childrens' Hospital of Illinois.

The **Padre Island Parrot Head Club of CC** collected Non-Perishable Pantry Supplies for Flour Bluff Kinder Food Pantry, collected toys for Toys for Tots and bought a Christmas Tree to be decorated (club members providing Tropical Christmas Ornaments) which was auctioned with monies going to Timon's Ministries. They adopted a family of seven and provided them with Christmas Dinner and donated Christmas Gifts to Ronald McDonald House in Corpus Christi, TX.

Chicago Parrot Head Club is happy to report the final numbers from Summer Chi.ill in August that raised \$18,881 for Cornerstone Services, Inc. They also raised \$12,380 for their Alzheimer's Walk Team in October, and donated \$500 to the Chicago Zoological Society. They decorated a large Christmas Tree at the zoo as a club social in November.
